Terms & Conditions

Insurance: LFC Academy venues will be covered by public liability insurance but not for loss of belongings or damage to vehicles or personal accident. Personal accident will be provided for trips organised by the LFC Academy. An injury report form is available from committee members, coaches and youth development officer. Injury reports forms must be completed immediately after the incident (within a few hours) and must include input and signatures from the coach of the session and a witness to the incident.

Medical Consent Form: LFC Academy will not permit any child to participate in LFC Academy activity without a medical consent form signed by their parent(s)/guardian(s). LFC Academy reserves the right to refuse an applicant based on the information provided in the medical consent form if the club is unable to provide suitable adequate care.

Damages/Injuries/Loss of Possessions: LFC Academy staff are accredited coaches who will implement the highest safety measures. LFC Academy will not be held responsible for damages, injuries or loss of possessions. We strongly recommend that all valuables be left at home. All players may be asked to assume the position of goalkeeper from time to time. The parent/guardian of any child who does not wish their child to assume this position must make it known to the Youth Development Officer/facilitator. In the absence of such notification it shall be deemed that the guardian has consented to their child assuming goalkeeping position if requested to do so by a coach.

Conduct: Participants must follow the instructions of the coaching staff in charge. Misbehavior or bullying may result in the participant being expelled from LFC Academy and fees will not be refunded. Parents are requested to stay for training sessions. If a child is expelled from the Academy and does not have parental consent to travel to and from the venue independently, the parent/guardian or nominated person of the child shall be required to pick up the child immediately from the LFC Academy venue.

Weather: LFC Academy shall not be accountable should training sessions/fixtures be suspended or cancelled due to bad weather. LFC Academy will contact the parent/guardian to advise of the suspension/cancellation if necessary. It will then be the responsibility of the parent/guardian to make arrangements to collect their child. The coaching staff will supervise all children until they have been collected.

Mascots: LFC Academy may wish to present teams or individual players as mascots at Limerick FC football matches. If you do not wish for your child to participate in such activities, please let Youth Development Officer/facilitator aware of this as early as possible.

Membership fees + weekly subscription: Membership of €150 to be paid on joining. LFC Academy is not liable if it is unable to provide a fundraising event for raising of said fees. LFC Academy may then ask parents/guardians directly for fees. LFC Academy is not liable if our kit supplier is unable to provide one or all of items of kit to a child who has paid their fees. LFC Academy retains the right to change membership fees at any time. If membership fees are changed LFC Academy are not obliged to refund membership fees.
